Methodology & Logistics

Study Sample

 A total of 250 randomly selected residents of Newmarket, Ontario 18 years of age and older were interviewed.

Survey Method

 The survey was conducted using computer-assisted techniques of telephone interviewing (CATI) and random number selection. A total of 20% of all interviews were monitored and the management of Oraclepoll Research Limited supervised 100%.

Logistics

• The surveys were conducted between the days of September 24th and 25th 2007. Initial calls were made between the hours of 6:00 p.m. and 9:00 p.m. Subsequent callbacks of no-answers and busy numbers were made on a (staggered) daily rotating basis up to 7 times (from 10:00 a.m. to 9:00 p.m.) until contact was made. In addition, telephone interview appointments were attempted with those respondents unable to complete the survey at the time of contact. If no contact was made at a number after the seventh attempt, the number was discarded.

Confidence

• The margin of error for each 250-person survey is ± 6.2%, 19/20 times.


Executive Summary

BYLAW AWARENESS & SUPPORT

All respondents were first read a preamble outlining the pesticide bylaw prohibiting the use of cosmetic pesticides on private and public property and were then asked if they were aware of it. Eight in ten residents (80%) claimed that they were aware of it compared to 20% that were unaware.

Respondents were then asked the following





Slightly more than three-quarters of residents support the by-law, while only 18% oppose it and 6% were unsure or did not know. Opposition was higher among males (33%) and 45-54 year olds (33%).


Reasons for supporting the bylaw included being good for the environment (30%), health concerns over pesticides (14%), that they are harmful to children (12%), harmful to animals (7%), harmful in general (7%) and pose risks to ground water (7%).

On the other hand, those opposed to the by-law felt that there would be too many weeds otherwise (17%), that they are needed to control weeds (15%), there are no alternatives (13%), they are not harmful (9%) and that Council should deal with more important issues (9%).

LAWN / GARDEN MAINTENANCE

A total of 76% of residents surveyed have both a lawn and garden, 16% only a lawn, 2% a garden, while 6% have neither a lawn nor garden. Among those with a lawn or garden, 80% self maintain their property, 14% use a landscaping company and 6% both self maintain and use a yard service firm.

Residents with lawns, gardens or both lawns and gardens that self maintain their own lawn were asked the following.



"Do you currently use cosmetic or nonessential lawn pesticide chemicals on your home lawn or garden to control weeds and insects?"


Only 20% of those with lawns, gardens or both currently use cosmetic or nonessential pesticides. Pesticide users have them applied to control weeds (88%), to maintain lawn health (63%), to maintain an attractive lawn (63%), to control insects (50%) and to remove pests from hard surfaces (45%).

A total of 37% of those that self maintain their lawn have at one time used environmentally safe alternatives.

Respondents that self maintain and currently use cosmetic pesticides were asked the following.


"If you were provided with information on methods to have a lawn and garden that are free of cosmetic pesticides and also free of weeds, what would be the likelihood that you would stop using them?


Please respond using the scale where one is not at all likely and five is very likely."



A total of 71% of those using pesticides stated that they would stop using them if provided with alternatives.

Residents that use a landscaping or lawn maintenance service were asked the following.





One-third of those who use lawn maintenance or landscaping services stated that their company uses cosmetic pesticides. These pesticide users have them applied to control weeds (82%), to maintain lawn health (82%), control insects (73%) and to maintain an attractive lawn (46%). Only 18% of these residents said that their lawn service provider has presented them with alternatives to these chemicals.

LAWN MAINTENANCE

Residents with lawns and or gardens were questioned about their primary source for information about lawn care issues. A total of 21% stated that they get this information from a website, 13% said from their lawn care company, 12% from friends, 7% books or magazines, 6% television and 6% a store. 9% do not obtain any information, 4% just do what they always have or what their parents did and 3% did not know.

Respondents that use pesticides were then asked about what would encourage them to eliminate the use of these chemicals. A fact sheet (25%) was most named, followed by brochures (14%), newspaper articles (13%), having alternatives available (8%), a testimonial from someone was has already done so (7%) and information from a lawn care company (7%). A total of 12% did not know or were unsure.

All respondents were asked to agree or disagree with the following statements.

A majority of Newmarket residents agreed with each of the three statements and especially with respect to the environmental risks posed by pesticides and the health threat they pose to children.
