COMMENTS

In response to the additional costs to the Old Town Hall project for the replacement of the foundation, the CAO and Commissioner provided Council with Joint Report 2013-38 and identified the following sources for funding:

- 1. Existing Contingency Funds in the amount of \$250,000 (minimum)*
- 2. Reductions in the Project Budget totaling \$325,000 (maximum)
- Contributions from public art contributions from new development and other sources totaling \$325,000 (maximum)
- 4. Additional contribution from the Asset Replacement Fund of \$500,000
- Note *: The contingency sum will be utilized to the maximum amount available which will be determined as the project proceeds.

The Contingency Funds have been reduced to the amount of \$250,000 and the following will or have been taken out of the project to achieve the project reductions:

One of the proposed project reductions was to delete the canopy connecting the drop off lane with the southerly entrance to the building. This feature has been considered significant to the operation of the building in terms of an outdoor performance area, public amenities and improved building maintenance.

The Town has been successful in acquiring a donation from Mr. Reininger of \$50,000 for this feature. In order to include the canopy in the building we must advise the contractor prior to the next Budget Task Force Meeting and we are therefore providing that direction. These funds will be attributed to the \$325,000 savings target and Staff will continue to finalize additional cost savings to the project to meet this savings target.
